RESCISSION OF AND AMENDMENT TO
PARAGRAPH 13 OF AMENDED AND
RESTATED DECLARATION OF RESTRICTIONS
FOR TRACT NO. 681

The undersigned, Declarant, under that certain Amended and Restated Declaration of Restrictions for Tract No. 681, recorded in the Office of the County Recorder of the County of San Luis Obispo, as Document 21282 at Volume 2409, pages 11 through 26, on May 25, 1982, hereby rescinds in its entirety, Paragraph 13 of said Document, at pages 5 and 6, and substitutes in its place, as an amendment thereto, the following language:

13. Water shall be supplied to this development by Afuera de Chorro Water Company and no individual water-supply system shall be permitted on any lot or parcel, except Lots 18 and 19.

Water from said mutual water company shall be used solely for domestic use and not for crop irrigation purposes or commercial use. Reasonable amounts, as determined by the Board of Directors of the Afuera de Chorro Water Company, shall be permitted to be utilized for watering noncommercial livestock.

"Crop irrigation" as used in this restriction shall not include use for watering of a personal or household garden where the crop is not resold commercially.

The owner of each lot or parcel shall be responsible for the construction and maintenance of all piping systems connecting his respective parcel to the Afuera de Chorro Water Company system.

The water wells in existence on Tract No. 681 at the time each lot or parcel is sold are reserved for the exclusive use of the Afuera de Chorro Water Company.
